**Note 1.** One time age relaxation in upper age limit shall be given to the primary teachers working in privately managed Government aided, recognized and Government schools to the extent of service rendered by them as a primary teacher subject to a **maximum of five years.**

**Note 2.** Professional Training Diploma or Certificate awarded by any State, Board or University other than Haryana Education Department will be recognized only if this Degree or Diploma or Certificate has been **recognized** by the **Haryana Government.**

AND

A Diploma/degree course in Teacher Education recognized by the National Council for Teacher Education (**NCTE**) only shall be considered. However, in case of Diploma in Education (Special Education) and B. Ed. (Special Education), a course recognized by the **Rehabilitation Council of India (RCI) only** shall be considered.

**Note 3.** A one time exemption of HTET/STET for teachers who till 11.04.2012 have worked for minimum 4 years in **privately managed Govt. Aided Schools, Recognized Schools and Govt. Schools.** Number of years is cumulative, candidate must be in service as PRT on 11.04.2012 and in position on the date of applying. The teaching experience must be as Primary Teacher after acquiring essential

qualification and supported by salary slip. They will have to qualify HTET not later than 1<sup>st</sup>, April 2015 otherwise their services will be terminated automatically.

- Note 4.** Four years teaching experience certificate for one time exemption for HTET/STET and one time upper age relaxation certificate issued by **Head of the Institute must be verified by DEEO** & counter signed by **Director of Elementary Education** of the concerned State even for CBSE/ Central Schools and Navodaya Vidhalaya. One time exemption implies that an applicant can apply only once for a particular category of post in the first advertisement. No such exemption will be granted in the subsequent advertisement.
- Note 5.** Candidates possessing **higher academic** or **professional qualification** will **not be eligible** unless they possess the minimum qualification including HTET or four years teaching experience as primary teacher.

**Appendix-A****HARYANA SCHOOL TEACHERS SELECTION BOARD (HSTSB)****SPECIAL INSTRUCTIONS FOR PRIMARY TEACHER**

1. Haryana School Teachers Selection Board (HSTSB) has been constituted vide Haryana Government School Education Department Notification 8/1-2011 Co. (1) dated 18-02-2012. The HSTSB will be directly recruiting Teachers, Teacher Educators and Education Supervisors for School Education Department. The Board office is in Hartron Bhawan, Bays No. 73-76, Sector-2, Panchkula, Haryana.
2. The prescribed essential qualification does not entitle a candidate to be called for interview. The Haryana School Teachers Selection Board (HSTSB) may short list the candidates for interview by holding a written examination or on the basis of academic criteria or percentage cut off to be adopted by the Board. The decision of the Board in all matters relating to acceptance or rejection of an application, eligibility/suitability of the candidates and mode of criteria for selection etc. will be final and binding on the candidates. No inquiry or correspondence will be entertained in this regard.
3. Candidates applying must ensure that they fulfill all the eligibility conditions on the last date of application. If on verification at any time before or after the written examination or interview or appointment, it is found that they do not fulfill any of the eligibility conditions or it is found that the information furnished is false or incorrect their candidature will be cancelled.
4. **Note 1:-** Disabled ESM will mean ESM who while serving in the Armed Forces of the Union were disabled in operations against the enemy or in disturbed areas.

**Note 2:-** Dependents will include besides wife/widow, dependent sons/daughters.

- None of the persons below shall fall within the definition of word DESM in terms of Haryana Govt. Letter No. 12/37/79-GS11 dated 21-11-1980:-
  - a) A person may be working on an adhoc basis against the post advertised or somewhere else.
  - b) A person may be unemployed at the time of making the application but he may have other source of income viz. from agriculture, trade, property and bank balance etc.

His subsistence from the pool of the joint Hindu family with the consent of the Karta.

- The upper age limit in respect of widow, legally separated woman, divorcee, deserted woman and unmarried woman of Haryana will be up to 45 years as per Government instructions.
- For ESM candidates relaxation up to continuous Military service added by three years.
- For teachers working in privately managed Govt. Aided Schools, recognized schools and Government Schools one time upper age limit to the extent of service rendered by them as a teacher subject to a maximum of 5 years.

8. **EXPERIENCE:-**

Experience wherever applicable will be considered, only after acquiring the essential qualification and up to the last date of submission of application, along with salary.

9. **FEE:-**

- a) **Group-C Post** For General Category = Rs. 300/- For Reserved Category of Haryana (SC/BC) = Rs. 75/-

11. **Online :-**

#### **12. Printed Copy :-**

Printed copy of the application form with original certificates and photocopy will be brought by the candidate at the time of interview/verification alongwith Photo, Identity Proof i.e. Identity Card/Driving License/Passport/Voter Card/Pan Card etc.

#### **13. Examinations :-**

Candidate are required to give details of all examinations passed from matriculation or its equivalent onwards and mention total and percentage of marks obtained and maximum marks in each examination. For the Haryana HTET/STET examination passed, additional details of month and year of examination and the Roll Number be also given.

#### **14. Action against candidates found guilty of misconduct :-**

NCC B or C Grade Certificates and National/International level sports participation certificates will be brought.

4. 33% horizontal reservation for female candidates will be admissible to the domicile of Haryana State.

11. DESM candidate will bring an Affidavit to the effect that he/she was not ceased to be a DESM till today or any other member of his family has not taken benefit of DESM in Government Service.
12. PHC Candidates bring with him (40% & above disability certificate).

**NOTE:-**
